During the month of November I attended 3 roundups in Cambridge, Stratford and Orillia. In late December I received my Communications Kit for the 2015 General Service Conference April 19th – April 25th. This year's Conference theme is "Celebrating 80 Years of Recovery, Unity and Service – The Foundation for our Future". My Kit contained a timeline for the Conference fees, forums to be submitted. The Delegate's Fee is \$1600.00 us and is required by March 2nd, 2015. Total costs including the voluntary contribution are est. at \$7500.00 per Delegate.

A.A.W.S. has rolled out the new eBooks program, available through third-party vendors, beginning in January with the Big Book (Fourth Edition) in English, Spanish and French.

Last year at this time I emailed all the DCM's some information on Predators in A.A. I did encourage feedback but received none. I know that this problem has not gone away because I have received some inquiries this year on what to do, that's why I am bringing up this subject again. NOT EVERYONE IS LOOKING ONLY FOR SOBRIETY. . .

As a member of Alcoholics Anonymous, you want to be aware that not all those who attend AA meetings have only sobriety in mind.

Some members may try to take advantage of other members in various ways, such as:

- **sexual harassment**
- **sexual attack**
- **pressuring members to join a particular religious group**
- **borrowing money**
- **selling goods for personal gain**
- **offering investment schemes**
- **theft of group funds**

Should any of these situations arise for you, here are some suggested ways of handling them:

- Talk to other members about it and raise the matter at a group conscience meeting. Take care that you aren't just passing on rumors. Make sure you have well-established facts to work with.
- Discuss the problem with the person suspected of preying on other members. Listen to their side of the matter. Let them know the group disapproves of predatory behavior
- Make sure other members stay with the suspected predator whenever he or she is talking to vulnerable new members.
- Raise your concerns with any of the members you think may be at risk from the predator.

- Don't think the matter ends with your group. The predator may leave your group and move to fresh hunting grounds. You may need to warn members in other groups.
- Barring someone from meetings is an extreme step and should only be taken when other steps have failed.
- In certain situations you may need to notify the police.
- Under no circumstances should members resort to vigilante action and use violence to try to solve the problem. This would be totally against the spirit of the Fellowship and could turn the situation into a worse problem.

To all DCM's I will discussing this topic again at our Spring Assembly in DCM school as it is on the Agenda for the 2015 General Service Conference under
